62nd ANNUAL GENERAL MEETING and
129th EXTRAORDINARY GENERAL MEETING**

Shareholders of Companhia de Saneamento do Paraná - Sanepar are invited to participate in the Annual and Extraordinary General Meetings, which will be held at 11:00 a.m. on April 29, 2026, in accordance with Article 5, paragraph 3, of CVM Resolution No. 81/2022, at the Company's headquarters, located at Rua Engenheiros Rebouças, 1376, Curitiba, State of Paraná.

In order to promote greater accessibility and encourage shareholder attendance, the current meetings will be held exclusively in digital format, in accordance with CVM Resolution No. 81/2022, through the digital platform ALFM *Easy Voting*, to decide on the following agenda:

Annual General Meeting:

Item 1 – To resolve the Management Report and Financial Statements for the fiscal year ended on 12/31/2025;

II – To resolve the proposal for the Allocation of Profits for the fiscal year ended on 12/31/2025;

III – To establish the global amount of compensation for Management, Fiscal Council, and Statutory Committees, namely Statutory Audit Committee, Eligibility Committee, and Technical Committee;

IV – To resolve the election of the members of the Board of Directors.

Extraordinary General Meeting:

I – To deliberate on the amendment and restatement of the Articles of Association.

The documents related to the items on the agenda are available to shareholders on the Company's Investor Relations page (ri.sanepar.com.br) and on the CVM website (cvm.gov.br), in compliance with the provisions of CVM Resolution No. 81, dated March 29, 2022, and Law No. 6,404, dated December 15, 1976.

Shareholder's attendance method

The General Meetings will be held exclusively digitally, which is why shareholder attendance may occur through:

a) **Remote Voting Form – BVD:**

Voting may be exercised through custody agents, through the Company's share registrar, or directly to the Company via the email address easyvoting@alfm.adv.br, which will accept them until the end of the day on April 25, 2026.

b) **Digital Platform:**

For participation in the AGOE through the ALFM *Easy Voting* digital platform, the shareholder must complete the registration by the **end of the day on April 27, 2026**, by accessing the link:

Conditions for participation via the Remote Voting Form (BVD) or the Digital Platform must comply with the procedures and mandatory documentation set forth in the Participation Manual for the 62nd Annual General Meeting and the 129th Extraordinary General Meeting of the Sanitation Company of Paraná – SANEPAR.

The Annual and Extraordinary General Meetings will be conducted in the official language of the country.

Cumulative Voting

In compliance with the Brazilian Corporation Law and CVM Resolution No. 70, dated March 22, 2022, the minimum voting capital ownership required to request the adoption of the cumulative voting system for the election of the Board of Directors is 5% (five percent) of the voting share capital. As set forth in Article 141, Paragraph 1, of Law No. 6,404, dated December 15, 1976 ("Brazilian Corporation Law"), the request for the cumulative voting process must be sent to the Company, at least 48 (forty-eight) hours prior to the AGM/EGM, through the Company's Investor Relations department.
